What to Submit

We invite *Forum* submissions for the *Yale Law Journal* Volume 127 from all students, faculty, and practitioners. You may submit a *Forum* Essay, Response, or Collection topic or piece at any time.

YLJ Forum pieces are authored by professors, practitioners, and students, and they are generally shorter, timelier, and accessible to a general audience. We particularly encourage authors to submit pieces that grapple with current issues as they unfold and to write in a style targeted toward policymakers and practitioners. All YLJ Forum pieces are fully searchable and available on LexisNexis and Westlaw and are also made available in PDF format.

Submissions are reviewed by the Forum & Features Committee without knowledge of the authors' identities. We recommend that submissions be between 2,500 to 5,000 words (including footnotes).

- <u>Forum Essays</u> are original and timely pieces that bear directly on unfolding legal events, blending the common appeal of op-eds with the rigor of scholarship. For two recent examples, please see Triptych's End: A Better Framework To Evaluate 21st Century International Lawmaking by Professor Harold Hongju Koh and Predicting Utah v. Strieff's Civil Rights Impact by Professor Katherine A. Macfarlane.
- <u>Forum Responses</u> are scholarly reactions to our print and online content. The goal is for academics, practitioners, and students to use the *YLJ Forum* to engage with and challenge one another. *YLJ Forum* may feature multiple Responses to a given online or print piece. The Committee additionally may solicit responses to print pieces and symposia commentaries. For a recent example, please see Cindy Cohn's <u>Response</u> to The Fourth Amendment in the Information Age by Robert S. Litt.
- <u>Forum Collections</u> are explorations of a single legal subject, with authors contributing distinct perspectives and engaging in dialogue with each other. For a recent example, please see the Collection on the Freedom of Information Act, which included contributions from <u>David E. McCraw</u>, <u>Jameel Jaffer & Brett M. Kaufman</u>, <u>Melanie A. Pustay</u>, <u>Margaret B. Kwoka</u>, and <u>Beth Simone Noveck</u>. The Committee accepts submissions for Collection topics and pieces in addition to soliciting them.

How to Submit

The YLJ Forum accepts pieces on a rolling basis throughout the year, and you may submit your piece through the electronic system at any time.

All YLJ Forum pieces must be submitted through the Journal's online submission process. To

submit through our website, go to http://ylj.yalelawjournal.org/authors/index.html and register for an account. Once your account has been created, log in and click on the "Submit Work" hyperlink; after that, check the "Yale Law Journal Forum Piece" bubble and click on "Continue." Follow the instructions on that screen to submit all required documents. Submission materials must include the following and be uploaded into the appropriate fields on our website (preferably in Microsoft Word format):

- 1. *Submission field*. Upload the submission, without your name on it, into this field. This document should provide a word count, including footnotes, in the header.
- 2. *Preemption Paragraph field*. Upload your Preemption Paragraph, without your name on it, into this field. In no more than a couple hundred words, please explain your piece's relationship to any existing scholarship.
- 3. *Submission Form* (Student Authors Only). The Submission Form is a Google form that can be accessed from the Comment submissions upload page. It is also available here. The Submission Form will only be accessible to the Managing Editors.

Make sure to remove all identifying information from your submission. The *Forum* Committee reviews submissions anonymously and will not consider submissions that contain identifying information about the author. Additionally, please right-click all documents to be submitted, click on "Properties," and delete your name from all relevant fields under the Summary tab. Please note that the *Forum* Committee cannot review submissions that depart from any of these submissions guidelines. To preserve anonymity, all questions regarding the *YLJ Forum* submissions process should be directed to Executive Editor Meenakshi Krishnan (meenakshi.krishnan@yale.edu).

In order to ensure timely publication of essays, we follow an accelerated evaluation and production schedule. All citations should conform to standard *Bluebook* style. Please also make sure to include Internet links to sources wherever possible. The *YLJ Forum* attempts to provide quick access to all cited materials.
